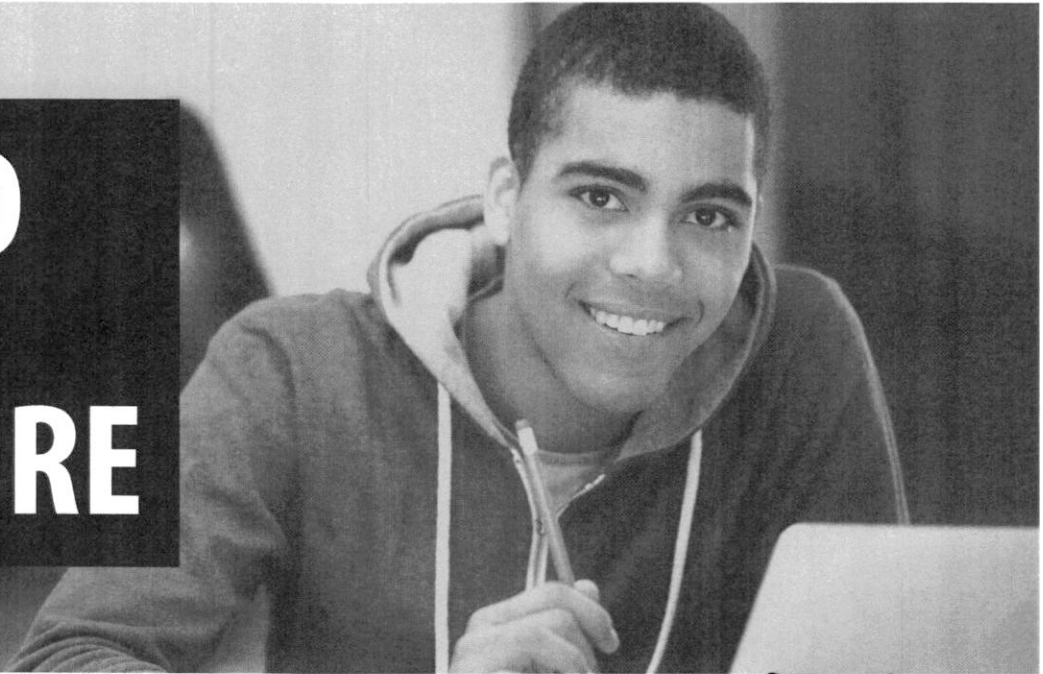

### What You Will Need

- Anyone under the age of 18 will need a parent/guardian as a joint owner on their account
- Student must provide one form of primary identification or two forms of secondary identification when opening the account
- Parent must provide one form of primary identification when opening the account
- A \$25 minimum deposit is required

#### ACCEPTED FORMS OF ID

##### PRIMARY

- Federal or State issued picture ID
- State issued driver's license
- State issued ID card
- Current school issued ID card

##### SECONDARY

- Social Security Card
- Birth Certificate

Other fees may apply. Refer to the Neighbors FCU fee schedule for additional details. Neighbors FCU is federally insured by NCUA.
